Rates: \$25 per night. Total amount due at time of registration via check or cash only. Any dishonored check will be subject to a \$35 returned check fee.

Each spot can have 1 tent. Each spot will receive a RV pass & vehicle pass. Campers are welcome park RV & vehicle in space if room allows. Only vehicles with a pass will be allowed onto grounds. Other visiting vehicles must park in the gravel lot located West of the RV park. The RV park gate will be closed after 8:00pm on Friday & Saturday & opened after 7:00am on Saturday & Sunday. If you feel you may need to travel during these times you may will need to park your vehicle in the gravel lot.
